The approval for the tentative scheduled events is conditioned upon Finger Lakes notifying the Board of the actual dates the events are to be held.

### D ITEMS TO BE APPROVED, DENIED OR DEFERRED BY THE BOARD

### 1. MONTICELLO RACEWAY REQUEST TO OFFER ADVANCED WAGERING

The Board approved the request by Monticello Raceway to offer advanced wagering during the previous night's simulcast for the following day's live racing programs.

This approval is conditioned upon, consistent with outlined procedures, that the advanced wagering voucher entitles the patron to the pari-mutuel tickets subsequently punched and that the presentation of the pari-mutuel tickets entitles the holder to payment.

The procedure was to be reviewed with the NYS Department of Taxation and Finance.

### 2. VERNON DOWNS REQUEST TO SUPPLEMENT ON-TRACK RACES WITH THE SIMULCAST OF IN-STATE RACES

The Board approved the request by Vernon Downs to conduct less than a 9-race card due to a shortage of horses and supplement its live race cards with the simulcasts from an in-state harness track during the weeks of April 23<sup>rd</sup> through April 26<sup>th</sup> and April 30<sup>th</sup> through May 3<sup>rd</sup>.

# 3. YONKERS RACEWAY REQUEST FOR WITHDRAWAL FROM CAPITAL IMPROVEMENT FUND FOR ADVERTISING AND PROMOTIONAL EXPENSES

The Board approved the request by Yonkers Raceway, of January 23, 1998, to withdraw \$38,774.64 from their Capital Improvement Fund for reimbursement of advertising and promotional expenses incurred and paid for.

# 4. YONKERS RACEWAY REQUEST FOR WITHDRAWAL FROM CAPITAL IMPROVEMENT FUND FOR GRANDSTAND DEMOLITION PROJECT

The Board approved the request by Yonkers Raceway to withdraw \$250,000 from their Capital Improvement Fund for expenditures incurred with the demolition of the Grandstand and the relocation of racing related services to the Clubhouse.

### 5. SUFFOLK REGIONAL OFF-TRACK BETTING CORPORATION REQUEST TO CONDUCT A HANDICAPPING CHALLENGE

The Board approved the request by Suffolk OTB to conduct a handicapping challenge at its Tele-A-Race branch located at 100 Adams Avenue, Hauppauge, New York, on Saturday, June 20, 1998, in accordance with the rules and regulations outlined, pursuant to Section 908 of the Racing, Pari-Mutuel Wagering and Breeding Law.

### 6. NEW YORK CITY OFF-TRACK BETTING CORPORATION REQUEST TO AMEND ITS PLAN OF OPERATION

The Board approved the request by New York City OTB to amend its plan of operation to appoint William Carnevale as President of the Corporation.

This approval is conditioned upon a satisfactory return of Mr. Carnevale's fingerprint cards.

### 7. NEW YORK CITY OFF-TRACK BETTING CORPORATION REQUEST TO AMEND ITS PLAN OF OPERATION

The Board approved the request by New York City OTB to amend its plan of operation to appoint Ira H. Block as Senior Vice President of Legal Affairs and General Counsel of the Corporation.

This approval is conditioned upon a satisfactory return of Mr. Block's fingerprint cards.

### 8. BATAVIA DOWNS REQUEST TO APPOINT RYAN RADZINSKI PROPERTY MANAGER

The Board approved the request by Batavia Downs to appoint Ryan D. Radzinski as property manager.

### 9. CAPITAL DISTRICT REGIONAL OFF-TRACK BETTING CORPORATION REQUEST TO AMEND ITS PLAN OF OPERATION

The Board approved the request by Capital OTB to amend its plan of operation to appoint Willis Vermilyea as a member of its Board of Directors representing Greene County.

### 11. EXTENSION OF TIME PERIOD OFF-TRACK BETTING CORPORATIONS HAVE TO ISSUE MONTHLY STATEMENTS

The Board approved an extension of time for Off-Track Betting corporations to file their monthly reports from 15 to 45 days after the end of each month. This will remain in effect through the end of the calendar year.

## 12. RECONSIDERATION OF RULE PROPOSAL FOR OVERNIGHT AND CLAIMING HANDICAP TOP WEIGHT

The Board approved a proposal to repeal Rule 4029.8 requiring that the top weight for overnight and claiming handicaps be not less than 122 pounds. This approval supercedes the partial appeal of Rule 4029.8, from the February 25, 1998 Board meeting.

13. CONSIDERATION FOR REINSTATEMENT OF PILTON CHANDLER
The Board approved the reinstatement of the license of harness groom Pilton Chandler
subject to his consent to and compliance with the Board's standard conditions for
reinstatement.
