<u>Guidelines For Conducting Bonus Ball Games During Double-Header</u> and Triple-Header Bingo Sessions¹

Conducting A Double-Header Session Using a 75% - 25% Split

Opportunities to participate in both occasions of a Double-Header may be sold prior to the first occasion in that session, provided the proceeds from the total sales of Bonus Ball opportunities is divided into two equal parts prior to the start of the first occasion, and those funds shall be separately reserved to represent the profits and prize monies for both the first and second occasions, as follows:

- (a) Exactly one-half of the total sales of Bonus Ball opportunities sold prior to the first occasion shall be processed pursuant to (c), below.
- (b) The remaining one-half of the total sale of Bonus Ball opportunities shall be reserved for the second occasion and processed pursuant to (e), below.
- (c) Twenty-five percent of the proceeds from the sale of Bonus Ball opportunities reserved for the first occasion shall be retained by the licensee as profit, and the remaining 75% shall be designated the Bonus Ball prize for the first occasion (or it shall be added to the Bonus Ball prize carried-over from the previous session, if applicable, to form the Bonus Ball prize for the first occasion).
- (d) If there is a Bonus Ball winner during the first occasion, the Bonus Ball prize designated for the first occasion shall be awarded, and an announcement shall be made that the Bonus Ball game is over for the remainder of the first occasion. If there is no Bonus Ball winner during the first occasion, the designated Bonus Ball prize shall be reserved to form the Bonus Ball carry-over prize in the second occasion.
- (e) Prior to the start of the second occasion in the Double-Header, twenty-five percent of the proceeds from the sale of Bonus Ball opportunities reserved for the second occasion shall be retained by the licensee as profit, and the remaining 75% shall be designated the Bonus Ball prize for the second occasion (or it shall be added to the Bonus Ball prize carried-over from the first occasion, if applicable, to form the Bonus Ball prize designated for the second occasion).
- (f) If there is a Bonus Ball winner during the second occasion, the Bonus Ball prize designated for the second occasion shall be awarded, and an announcement shall be made that the Bonus Ball game is over for the remainder of the session. If there is no Bonus Ball winner during the second occasion, the designated Bonus Ball prize shall be reserved to form the Bonus Ball carry-over prize for the first bingo occasion of the next session.

Note: If the Bonus Ball prize reaches \$6,000 all proceeds collected thereafter shall be retained by the licensed authorized organization as profit until the \$6,000 bonus ball prize is awarded.

Conducting A Triple-Header Session Using a 75% - 25% Split

Opportunities to participate in all three occasions of a Triple-Header may be sold prior to the first occasion in that session, provided the proceeds from the total sale of Bonus Ball opportunities is divided into three equal parts prior to the start of the first occasion, and those funds shall be separately reserved to represent the profits and prize monies for the first, second and third occasions, as follows:

- (a) Exactly one-third of the total sale of Bonus Ball opportunities sold prior to the first occasion shall be processed pursuant to (d), below.
- (b) One-third of the remaining sales of Bonus Ball opportunities shall be reserved for the second occasion and processed pursuant to (g), below.
- (c) The remaining one-third of the sales of Bonus Ball opportunities shall be reserved for the third occasion and processed pursuant to (h), below.
- (d) Twenty-five percent of the proceeds from the sale of Bonus Ball opportunities reserved for the first occasion shall be retained by the licensee as profit, and the remaining 75% shall be designated the Bonus Ball prize for the first occasion (or it shall be added to the Bonus Ball prize carried-over from the previous occasion, if applicable, to form the Bonus Ball prize for the first occasion).
- (e) If there is a Bonus Ball winner during the first occasion, the Bonus Ball prize designated for the first occasion shall be awarded, and an announcement shall be made that the Bonus Ball game is over for the remainder of the first occasion. If there is no Bonus Ball winner during the first occasion, the designated Bonus Ball prize shall be reserved to form the Bonus Ball carry-over prize in the second occasion.
- (f) Prior to the start of the second occasion in that Triple-Header, twenty-five percent of the proceeds from the sale of Bonus Ball opportunities reserved for the second occasion shall be retained by the licensee as profit, and the remaining 75% shall be designated the Bonus Ball prize for the second occasion (or it shall be added to the Bonus Ball prize carried-over from the first occasion, if applicable, to form the Bonus Ball prize designated for the second occasion).
- (g) If there is a Bonus Ball winner during the second occasion, the Bonus Ball prize designated for the second occasion shall be awarded, and an announcement shall be made that the Bonus Ball game is over for the remainder of the second occasion. If there is no Bonus Ball winner during the second occasion, the designated Bonus Ball prize shall be reserved to form the Bonus Ball carry-over prize for the third bingo occasion in that Triple Header.

- (h) Prior to the start of the third occasion in that Triple-Header, twenty-five percent of the proceeds from the sale of Bonus Ball opportunities reserved for the third occasion shall be retained by the licensee as profit, and the remaining 75% shall be designated the Bonus Ball prize for the third occasion (or it shall be added to the Bonus Ball prize carried-over from the second occasion, if applicable, to form the Bonus Ball prize designated for the third occasion).
- (i) If there is a Bonus Ball winner during the third occasion, the Bonus Ball prize designated for the third occasion shall be awarded, and an announcement shall be made that the Bonus Ball game is over for the remainder of that bingo session. If there is no Bonus Ball winner during the third occasion, the designated Bonus Ball prize shall be reserved to form the Bonus Ball carry-over prize in the first occasion of the next bingo session.

Note: If the Bonus Ball prize reaches \$6,000 all proceeds collected thereafter shall be retained by the licensed authorized organization as profit until the \$6,000 bonus ball prize is awarded.
