Amendment 1

THIS AGREEMENT made this 27 day of March, 2014 by and between the NEW YORK STATE GAMING COMMISSION, DIVISION OF LOTTERY, an executive agency of the State of New York having an office at One Broadway Center, Post Office Box 7500, Schenectady, New York 12301-7500 (the "Commission"), and Go Plastics, LLC having an office at 515 Brown Industrial Parkway, Canton, GA 30114 (the "Contractor").

WHEREAS the Parties entered into Contract #C140002 (the Agreement) on February 26, 2014 to provide Lottery Play Centers to the Lottery; and

WHEREAS the Contractor and the Lottery wish to amend the Compensation provision;
and

NOW, THEREFORE, in consideration of the foregoing and of the mutual promises hereinafter set forth, the parties hereto agree as follows:

1. Section 3 of of the Agreement is deleted and replaced with the following:

3. Compensation. In full consideration for all goods and services specified in the IFB and the Bid, the Commission agrees to pay, and the Contractor agrees to accept, compensation in accordance with the prices set forth in the Bid Form. No minimum

amount is guaranteed by this Agreement and the Contractor shall not have any right to make a claim therefor. The contract value for the term is not to exceed \$2,103,033.40.

2. All other provisions of the Agreement, as amended, remain in full force and effect.
