Incredible Technologies, Inc. Ownership and Officer Organization Chart

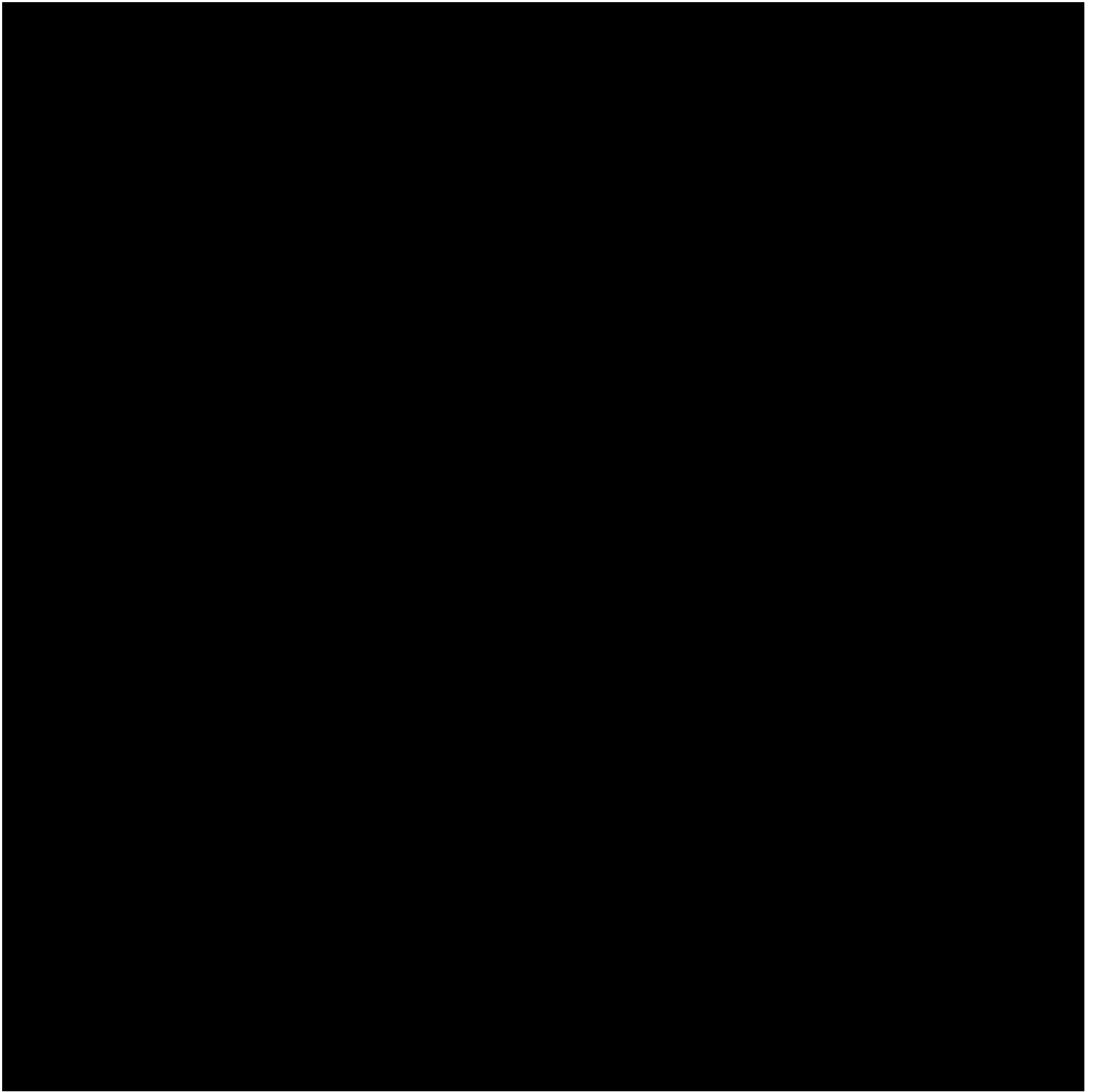


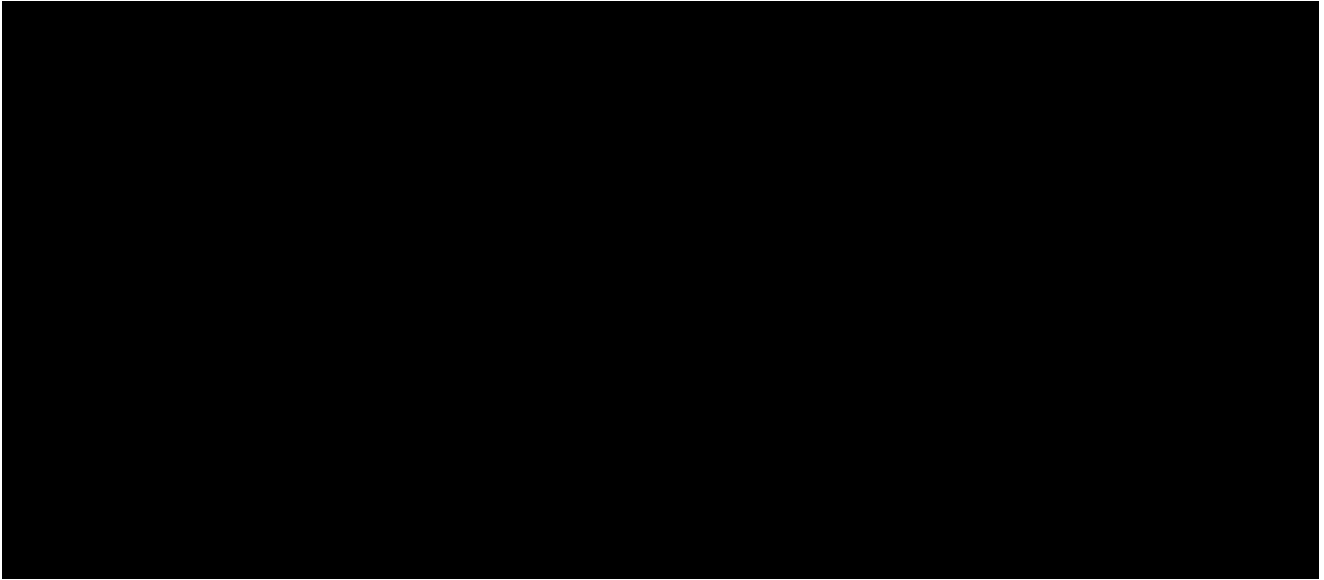
