**Statement of Work - #1**

This Statement of Work includes requested additional options in accordance with the Full Service Lottery System Agreement (Contract #C080005) entered into by and between the New York State Division of the Lottery and GTECH CORPORATION.

Commencement Date: Upon approval of the Office of State Comptroller  
Estimated Completion Date: Throughout the term of the contract  
Estimated Cost: \$1,673,100 (based on estimated order of 1,300)

**Detailed description of option, enhanced services, system upgrades, required support or maintenance:**

**Dual Jackpot Wireless Signage:**

GTECH to provide dual in-store wireless signage capable of displaying information regarding jackpot amounts, winning number information, advertisements, or Lottery authorized announcements. The wireless capability should operate only at short range, nominally on the order of up to 100 feet. Radio signals must be designed so as not to interrupt or interfere with any electronic devices otherwise operated in the store or carried by store customers or employees in the store.

The price shall be \$8.25 weekly per unit based on units of 500 amortized over 36 months (156 weeks) or the remainder of the contract, whichever is less and includes the hardware and software, installation, and maintenance (repair or replacement) for the initial term of the contract.

It is understood by both parties that if the contract has less than 36 months remaining, the amount of the payments by the Lottery will be increased in order for GTECH to recapture the full cost over the shorter time period.
