

Names, Addresses and Ownership and Other Interests

Stock in each of Caesars Entertainment Corporation (NASDAQ: CZR) (“CEC”) and Caesars Acquisition Company (NASDAQ: CACQ) (“CAC”) is publicly traded on NASDAQ. The sole member of the Applicant (Woodbury Casino, LLC) is Caesars Growth Partners, LLC (“CGP”). CAC holds 100% of the voting units of CGP. The sole member of the Manager is Caesars Entertainment Operating Company, Inc. (“CEOC”). CEC is CEOC’s sole shareholder.

The following persons and entities have a direct or indirect ownership or other proprietary interest in the Applicant and/or the Manager of five percent (5%) or more:

- CGP (sole member and 100% owner of the Applicant)
- CAC (holds 100% of the voting units of CGP and 42.4% of the economic interests in CGP)
- Harrah’s BC, Inc. (34.4% economic interest in CGP, holds 59.7% of the non-voting units in CGP)
- HIE Holdings, Inc. (23.2% economic interest in CGP, holds 40.3% of the non-voting units in CGP)
- HIE Holdings Topco, Inc. (owns 62.5% of the preferred shares issued by HIE Holdings, Inc.)
- CEOC (sole shareholder of HIE Holdings Topco, Inc. and sole member of the Manager)
- CEC (sole shareholder of CEOC and Harrah’s BC, Inc.; also holds 37.5% of the preferred stock in HIE Holdings, Inc.)
- TPG Hamlet Holdings, LLC (holds 18.1% of the stock in CAC and 16.2% of the stock in CEC)
- TPG Hamlet Holdings B, LLC (holds 2.5% of the stock in CAC and 2.2% of the stock in CEC)
- Apollo Hamlet Holdings, LLC (holds 9.7% of the stock in CAC and 8.6% of the stock in CEC)
- Apollo Hamlet Holdings B, LLC (holds 11% of the stock in CAC and 9.8% of the stock in CEC)
- Affiliates of Paulson & Co., Inc. (hold 9.1% of the stock in CAC and 9% of the stock in CEC)
- Co-Invest Hamlet Holdings, Series LLC (holds 6.5% of the stock in CAC and 6.7% of the stock in CEC)
- Co-Invest Hamlet Holdings B, LLC (holds 18.6% of the stock in CAC and 17.3% of the stock in CEC)
- Hamlet Holdings LLC (holds an irrevocable proxy to vote approximately 66.3% of the shares of CAC and 63.9% of the shares of CEC)
- Leon Black (holds 16.7% of the membership interests in Hamlet Holdings LLC)
- Marc Rowan (holds 16.7% of the membership interests in Hamlet Holdings LLC)
- Josh Harris (holds 16.7% of the membership interests in Hamlet Holdings LLC)
- David Bonderman (holds 25% of the membership interests in Hamlet Holdings LLC)
- James Coulter (holds 25% of the membership interests in Hamlet Holdings LLC)
