

Exhibit X.A.5 – Treatment and Prevention

Submit as Exhibit X.A.5. a description of plans to coordinate with local providers to facilitate assistance and treatment for those with gambling-related problems and plans to develop prevention programs targeted toward vulnerable populations.

A third outpatient problem gambling treatment program is just 15 minutes away in Troy: the Hudson-Mohawk Recovery Center.



Prior to opening the East Greenbush facility we will begin to develop a relationship with these local problem gambling treatment providers, and any others that may enter the area, by organizing meetings between key members of our staff (e.g., personnel who process self-exclusion applications) and members of local gambling treatment agencies. We believe it will be beneficial to our local patrons who seek assistance for a gambling problem if we are able to describe and demonstrate familiarity with treatment providers in the area. We will seek further opportunities to remain engaged with local gambling treatment providers and advocate for their participation as a co-trainer or speaker for our employee responsible gambling training sessions.

Plans to develop prevention programs targeted toward vulnerable populations

In addition to OASAS funding two local gambling treatment programs near our proposed East Greenbush facility, OASAS funds 12 prevention centers within a 45-mile radius of East Greenbush. One of these sites is the New York Council on Problem Gambling (NYCPG) located in Albany. We view close proximity to the NYCPG as a distinct advantage to the success of our responsible gaming efforts as we recognize the NYCPG as a valuable resource. We plan to work closely with the NYCPG and seek their expertise and guidance in helping us continually develop our responsible gaming and problem gambling awareness programs. Likewise, we will seek opportunities to join NYCPG efforts to support prevention programs targeting vulnerable populations. One such example is coordinating with the NYCPG and other local prevention centers to develop and promote activities related to Problem Gambling Awareness Month, which takes place each March. We will also explore opportunities to become involved with community coalitions established by local prevention centers such as the Capital Region Healthy Communities Coalition.

In addition to supporting community prevention program efforts, CVCR will implement prevention programs within our facilities. These include programs to prevent underage gambling, prevent underage consumption of alcohol, prevent the development of a gambling problem through responsible gaming promotion, guard against child endangerment, and implement policies and programs to maintain the health and safety of our employees. A description of many of these efforts is provided in Exhibit X.A.1. through Exhibit X.A.4. One area not discussed in prior responses is our vigilance in protecting the safety of children who are on our premises. Our staff will be trained to react responsibly and appropriately when a child appears to be unsupervised by an adult. Additionally, security personnel are assigned to patrol facility parking areas and keep a watchful eye for unattended children in parked vehicles. Protocols will be in place to involve local police if we observe child endangerment, elder abuse, or elder neglect. See Exhibit X.A.5. <h3>Underage Gaming and Unattended Children</h3> <p>The management of Saratoga Casino and Raceway believes that the Company has a moral, social, and business responsibility to promote responsible gaming by its employees and patrons and to strictly enforce minimum legal wagering ages.</p> <p>All employees at Saratoga Casino and Raceway are trained to respond when an underage patron is suspected in the gaming facility, placing bets at mutual windows, or cashing in winnings. They are further trained to react responsibly and appropriately when a child appears to be unsupervised by an adult.</p> <p>For the safety of our operation, employees, patrons, and the children of the community, we are diligent in our efforts to deny access to any person under the age of 18 years old onto the gaming floor or to wager at mutual windows. We also strictly adhere to our policy of zero tolerance for unattended children and act accordingly when a child is observed without adult supervision.</p> <p>In the event that you identify or find an unattended child(ren) anywhere on Saratoga Casino and Raceway property please contact the Security Department immediately at 518-581-5757.</p> <h4>What are acceptable forms of identification?</h4> <p>There are six different types of photo IDs that are acceptable for entrance into the gaming facility playing video gaming machines or wagering on horse races. They are:</p> <ul style="list-style-type: none"> • Valid state driver's license • Valid state identification card • U.S. Military ID • U.S. or international passport • Merchant Marine ID • Alien registration card 	<h4>What are unacceptable forms of identification?</h4> <p>Unacceptable IDs are those that are expired, lack a photograph, are not government or state issued, or are torn or mutilated. These include:</p> <ul style="list-style-type: none"> • Work badges • College ID cards • Credit Cards/ Store membership cards • Health insurance cards <h4>Can I bring my child into the gaming facility with me while I play?</h4> <p>No. No persons under the age of 18 years are permitted in the gaming facility except to reach a destination not on the gaming floor while being escorted by security and an adult or someone over the age of 18. This includes babies in carriers or car seats and toddlers in strollers.</p> <h4>Are children permitted at the betting (mutuels) windows?</h4> <p>Children under the age of 18 years old are not permitted to place wagers or collect winnings at the mutual windows.</p> <h4>Are children permitted in other areas of Saratoga Casino and Raceway?</h4> <p>Children are welcome with adult supervision on the Mezzanine, in the Grand Stand, in the Clubhouse, in the outside seating area by the track and in Fortunes, our full service restaurant and buffet. Children are also permitted to attend any outside event we hold on site.</p> <h4>Do you provide any type of child care on property?</h4> <p>No. At this time there is no on-site day care facility or program. Please plan your visit accordingly if you would like to participate in our video gaming entertainment.</p>
