Saratoga Harness Racing, Inc. has had the following disciplinary actions brought against it by a gaming licensing authority during the past five (5) years:

- New York State Gaming Commission Violation Notification 13-003. The Company's Director of VGM Operations was reprimanded for authorizing a move of games without appropriate approval of the Gaming Commission.
- New York State Gaming Commission Violation Notifications 13-009 and 13-024. In both of these instances, minors gained access to the gaming floor, but in neither case did the minor engage in gaming activity. The company was reprimanded for allowing minors to access the gaming floor and undertook remedial actions to prevent a recurrence.

Colorado Division of Gaming Warning Letter Case Report No. 13-000806. The Colorado licensee of Saratoga Harness Racing, Inc., failed timely to report a surveillance camera outage. No further action was taken.

No Applicant Party with respect to Hudson Valley Gaming, LLC (a member of Hudson Valley Casino and Resort, LLC) has had a disciplinary action brought against it by any gaming licensing authority during the past five (5) years.
