Each of Mohegan Gaming New York, LLC and Mohegan Resorts New York, LLC is a wholly-owned subsidiary of Mohegan Resorts, LLC, which is in turn a wholly-owned subsidiary of Mohegan Gaming & Hospitality, LLC. Mohegan Gaming & Hospitality, LLC is a wholly-owned subsidiary of MTGA Gaming, LLC. All of the above are manager-managed limited liability companies. MTGA Gaming, LLC is a wholly-owned subsidiary of the Mohegan Tribal Gaming Authority, a proprietary and governmental instrumentality of the Mohegan Tribe of Indians of Connecticut.

All assets of the Mohegan Tribe, including all gaming assets and the above entities, are owned on an undivided, collective basis for the benefit of the Mohegan Tribe. As a result, there are no individual natural person owners of the 50.1% interests in the Applicant ultimately owned by the Mohegan Tribe, and the Applicant is majority-owned by a federally-recognized Native American Tribe.

Based on guidance from the Location Board in its earlier questions and answers, the Mohegan Tribe is not an entity applicant included with this application because its gaming authority, the Mohegan Tribal Gaming Authority, has responsibility and control over all gaming matters related to this project.
