AMENDED BROWNFIELD SITE CLEANUP AGREEMENT

WHEREAS, the Brownfield Cleanup Agreement, Index No. W3-1004-04-06, (the "BCA") for Site No. C353008 (the "Site") was fully executed on May 19, 2005; and

WHEREAS, pursuant to the Stipulation and Order (the "S&O") "So Ordered" by the Honorable Burton Ledina, Judge of the Sullivan County Court, and filed in the Sullivan County Clerk's Office on July 30, 2009, Concord Associates, L.P.'s BCP application submitted under cover dated July 16, 2008 for 20.579 acres, delineated on "Exhibit B" of the S&O, was granted as an enlargement of BCP site C353008; and

WHEREAS, by certified amendment application for change in party dated July 7, 2009, Concord Kiamesha LLC, a Delaware limited liability company, with offices at 115 Stevens Avenue, Valhalla, New York 10595, requested to be added as a Volunteer to the BCA; and

WHEREAS, by certified acknowledgment of the amendment application for change in party dated July 7, 2009, Concord Associates, L.P. has agreed to Concord Kiamesha LLC's request and to execute an amendment; and

WHEREAS, the Department has accepted the amendment application to add Concord Kiamesha LLC as a Volunteer to the BCA.

NOW, THEREFORE, IN CONSIDERATION OF AND IN EXCHANGE FOR THE MUTUAL COVENANTS AND PROMISES, THE PARTIES AGREE TO THE FOLLOWING:

- 1. The 20.579 acres, as delineated on "Exhibit B" of the S&O which copy is attached hereto for reference, is incorporated into OU-1A of the Site; and
 - 2. Concord Kiamesha LLC is added to the BCA as a Volunteer; and
- 2. The BCA and this Amended BCA shall constitute the entire Agreement between the parties with all the terms and conditions of the Agreement, except as provided herein, remaining in full force and effect; and
