Explanation of Contracts with State of New York

1. Genting New York LLC , a subsidiary of Genting Americas Inc., entered into a Memorandum of Understanding with the State of New York, by and through the Governor, the Temporary President of the Senate and Speaker of the Assembly, on September 13, 2010, as amended, (the "MOU") for the development and operation of a video lottery terminal facility at the Aqueduct Racetrack in Queens, New York.
2. In connection with the MOU, on September 13, 2010, Genting New York LLC also assumed a groundlease from the State of New York for a certain area at the Aqueduct Racetrack as well as the Aqueduct Racetrack Facility.
3. Genting New York LLC , a subsidiary of Genting Americas Inc., entered into a sublease agreement with the New York Racing Association on September 13, 2010, as amended, as required by the MOU, for certain space within the Aqueduct Racetrack Facility.
4. Genting New York LLC, a subsidiary of Genting Americas Inc., entered into a Grant Disbursement Agreement with the New York State Urban Development Corporation d/b/a Empire State Development Corporation, approved by the New York State Attorney General on January 25, 2011, as required by the MOU, for certain development and renovations at the Aqueduct Racetrack Facility.
5. Genting New York LLC , a subsidiary of Genting Americas Inc., entered into an agreement with the New York Racing Association on July 23, 2011, as amended, for operation of all food and beverage outlets within the area subleased by the New York Racing Association of the Aqueduct Racetrack Facility.
6. In 2011, Genting New York LLC , a subsidiary of Genting Americas Inc., entered into three contracts with the Port Authority of New York and New Jersey to lease space adjacent to the Aqueduct Racing Facility for parking. The agreements were/are as follows:
 - a. AYE-174, executed November 2, 2011, as amended, for a term of 10 years.

- b. AYE-154, for a term from July 2011-October 2011.
 - c. AYE-182, for a term from July 2011-August 2011.
7. On September 23, 2011, Genting New York LLC , a subsidiary of Genting Americas Inc., entered into an operating and license agreement with MTA Bus Company (a division of the Metropolitan Transit Authority) for the diversion of the Q37 bus onto the property operated by Genting New York LLC at the Aqueduct Facility Property.
 8. On May 16, 2012, Genting New York LLC, entered into a development and license agreement with New York City Transit (a division of the Metropolitan Transit Authority) for redevelopment of and connection to the Aqueduct Racetrack Subway Station on the “A” line of the MTA subway system.
