Figure X. A.2-1a. Disclaimer Slot Machine Plaque

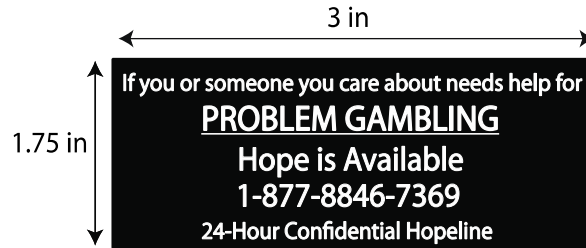
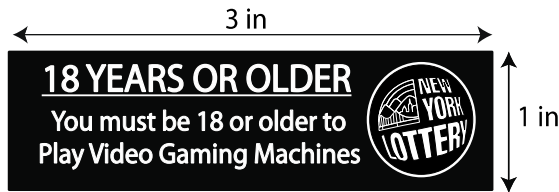


Figure X. A.2-1b. Disclaimer Slot Machine Plaque

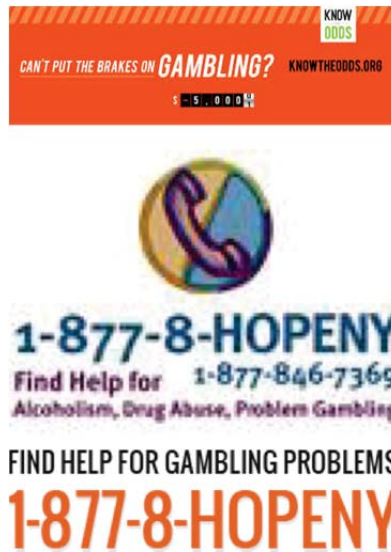


Figure X. A.2-4. Resorts World Hudson Valley Responsible Gambling Landing Page
