Dear Ms. Tinney,

As the Gaming Commission and its Siting Board deliberate the important decision of which developer will be granted license to build and operate a full gaming casino in the Eastern Southern Tier region, please forward this letter as an emphatic endorsement of the proposal presented by Tioga Downs.

This endorsement is not lightly made but, rather, is the result of extensive analysis by this organization's Public Affairs Council and Board of Directors. It is more pragmatic than parochial and is, hopefully, both visionary and contemporary. It is made on behalf of the Chamber of Commerce and our affiliated Convention and Visitors Bureau.

Certainly, a commanding consideration is the daunting record by Tioga Downs of deadlines met and promises kept. The employment, programming, facility enhancements, marketing, investment, performance, revenues and taxes, along with pervasive local and regional community support, have all been stellar. While these achievements are commendable, they are more significant as a demonstration of fulfillment which is unique among the proposals in the region.

As you well know, there are other components which distinguish the Tioga Downs proposal. For example, the Nichols location is beyond the competitive reach and redundancy of the Catskills and other Upstate regional casino sites as well as those of Pennsylvania. On the other hand, Nichols is ideally located as the gateway to the Finger Lakes for that burgeoning tourism region's most lucrative markets.
