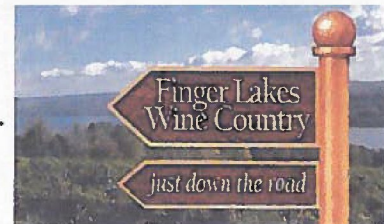

Dear Ms. Sauerbrey,

It is my pleasure to inform you that Tioga County, New York, is now eligible for membership in Finger Lakes Wine Country Tourism Marketing Association (FLWCTMA).

FLWCTMA was organized as an entity in 2000 with one purpose in mind—to promote economic development in the Finger Lakes region of the state of New York. A strong tourism industry adds depth to a community, making it much more desirable to live and work. It is the belief of area employers and civic leaders that everyone benefits from a community rich in history, culture, attractions and scenic beauty.

A unified branding initiative with strategic marketing and promotional programs attracts tourists to the Finger Lakes region. Critical mass affords opportunity and collectively, the area has a diverse product offering. Our target audience is the touring vacationer coming from a 150-500 mile radius. Marketing under the brand Finger Lakes Wine Country, "Finger Lakes" places us on the map in terms of geography, "Wine" is our unique differentiator as the largest wine producing region east of the Rocky Mountains, and "Country" conveys the message that we have a basket of disparate attractions with a broad visitor appeal.

Until yesterday's board decision, FLWCTMA's membership was limited to tourism-related organizations in Chemung, Steuben, Schuyler and Yates counties, and the member wineries of the Keuka, Seneca and Cayuga Lakes Wine Trails. On May 29, 2014, the Board of Directors of Finger Lakes Wine Country Tourism Marketing Association approved the following growth guidelines for the organization:

Public County Funding (applies to new growth, not existing county partnerships)

County must be within NY's designated 14 county Finger Lakes region

County must be contiguously connected to a current funding county of FLWCTMA

County must sign a three-year contract

Funding level – Counties with a population < 60,000 = \$60,000 annual investment + \$40,000 one time equity payment

Therefore the Tioga County Local Development Agency (LDC), d.b.a. "Tioga County Tourism Office," is now eligible to join Finger Lakes Wine Country Tourism Marketing Association as a county partner of the organization. Full membership in FLWCTMA is contingent upon Tioga Downs Racetrack, LLC being awarded a full casino gaming license, receipt of a one-time equity payment of \$40,000 and an annual investment of \$60,000 for a minimum of three (3) years.

The Tioga County Legislature will make available to the LDC a portion of monies earned from all county hotel motel room tax generated, including those from the completion and occupancy of the new Tioga Downs Hotel. These monies will be used to support the \$60,000 minimum annual investment for Tioga County to continue as a county partner with Finger Lakes Wine Country Tourism Marketing Association.
