SUNY Broome Community College supports the establishment of a full-service casino within the Binghamton Metropolitan Statistical Area (BMSA), or Greater Binghamton, for the following reasons which I'm certain you will reference in your application but that SUNY Broome would like to emphasize for those reviewing applications:

The BMSA encompasses both Broome and Tioga counties, the core population of the Southern Tier, which together had a population of 251,725 according to the 2010 census. Binghamton itself hosts the confluence of three major highway systems feeding all points Upstate through their convergence in the city. Consequently, the Greater Binghamton region serves as a primary gateway from Pennsylvania and Downstate to all of Upstate, and especially the Finger Lakes Region, evidenced by the location of the Rte 81 state tourist Gateway Plaza just to Binghamton's south. NY Routes 17 (future I-86), 88 and 81 all converge here to link Greater Binghamton directly to Downstate and NYC via the NY Thruway and Palisades Pkwy and also to Syracuse, Oneonta and Albany and all points west along the PA border and south to the Scranton and Pocono regions.

This major arterial transportation network also carries significant Canadian travel to points north of the Southern Tier over the Canadian/New York border and vice versa. Consequently, there is a very large presence of food service and distribution companies in Greater Binghamton including both Maines Paper & Food Service and Willow Run Foods headquartered just south of Binghamton. These are two of the largest food distributors in the nation, serving a large region of restaurants and restaurant chains throughout the eastern United States, thus testifying to the significant benefits and proximity of this interstate highway connectivity in Binghamton. Maines is a \$3 billion company and one of the largest privately held in the country. Crowley Foods, a subsidiary of HP Hood, also maintains distribution headquarters in Binghamton and Frito-Lay has a large plant here. We are truly a Mecca for the food distribution industry. Binghamton, serving as the food transportation epicenter of Central New York, makes the placement of a full-service casino here a logical, strategic decision for New York.

Greater Binghamton thus has an established infrastructure to serve a major tourism influx. In fact the hospitality industry was one of the few which actually grew in the region during the recent Great Recession, demonstrating the economic foundation is already in place to support full gaming. Indeed, what better place to locate a casino with our existing abundance of hotels, restaurants, performance venues, and retail outlets in Greater Binghamton, all of which would benefit immensely by locating a casino here. Significantly, with all these assets, what Greater Binghamton and the BMSA lack to ignite a significant tourism boon is a major destination attraction such as a casino. We desperately need an economic shot in the arm here and a casino license absolutely would provide that shot.

Toward that end, SUNY Broome has submitted degree proposals in both Casino and Event Management to complement its long running and very popular Hotel/Restaurant/Hospitality Management Program. The intention of these programs is to serve the training needs of employees in the hospitality industry and future casino operations and related enterprises located in the area and throughout Upstate. Consequently SUNY Broome has made a significant investment through grants and capital projects toward the construction of a casino gaming laboratory on campus, with plans for a hospitality center eventually in downtown Binghamton to support one of our fastest growing economic sectors.

Already full-fledged casinos flank us with Turning Stone to the north and Mohegan Sun to the south in Pennsylvania. The lack of a full-fledged casino within the borders of the BMSA thus denies us the majority of the gaming tourism traffic that travels well past us or not quite to us with all the ancillary business and employment which would be impacted by that traffic which currently migrates to facilities to our north and south. Based on the regional assets highlighted here, we believe Binghamton is poised to ignite economically and we further believe a full-fledged casino will vastly accelerate economic growth in the region.

Without reservation, SUNY Broome Community College enthusiastically supports the awarding of a casino gaming license to the Greater Binghamton/Binghamton Metro Statistical Area.




