RESOLUTION Town of Afton



WHEREAS, the citizens of the State of New York overwhelmingly voted in the affirmative to amend section 9 of Acticle 1 of the Constitution to allow the authorization for up to seven Class 111 casinos in New York State, and

WHEREAS, the Governor announced that the first four casinos will be built in Upstate New York, including at least one in Region 5, which includes Broome County, and

WHEREAS, it is projected that the construction of these Class 111 casinos will promote significant job growth, increase aid to schools, and permit local governments to lower property taxes through revenues generated for the host communities and counties within the region, which will benefit Town of Afton in the event that a Broome County site is selected, now, therefore be it

RESOLVED, that in furtherance of the above goals, the Town of Afton hereby declares its support for awarding a cauno license to a destination resort in Broome County, and be it

FURTHER RESOLVED, that a copy of this resolution shall be sent to the New York State Gaming Commission, Governor Cuomo, and appropriate state elected officials.
